- For those who qualify, you can donate through your IRA or eligible retirement plans to satisfy your required minimum distribution (RMD). A distribution made payable to United Way of Green County is tax-free (up to \$100,000) and counts toward your required minimum distribution. United Way of Green County is a qualified 501(c)(3) non-profit organization; therefore this is considered a qualified charitable distribution (QCD).
