When looking at funding community programs and organizations, using United Way of Green County makes sense. Here are the criteria that an organization that requests funding must meet:

(1) They must have non-profit status and be in good standing. Organizations submit their financials, a list of their board members, and strategic plans.

(2) They must submit a proposal for a specific program request. This must include goals and outcomes. Programs that have received funding must also provide outcome data – did they do what they say they were going to do, what were the results, how many people were impacted, and is it sustainable.

(3) Organizations are paid three times per year – 50% in April, 25% in September, and 25% in November. This is to ensure that programs are in fact meeting the goals and objectives outlined in their applications.

(4) Because United Way has a global picture of what is happening all throughout Green County, we can ensure that programs are not being duplicated, and we can foster collaboration across organizations.







## **Financial Hardship Changes Over Time**

ALICE is an acronym for Asset Limited, Income Constrained, Employed households that earn more than the Federal Poverty Level, but less than the basic cost of living for the county (the ALICE Threshold). Households below the ALICE Threshold - ALICE households plus those in poverty - can't afford the essentials.


As circumstances change, households may find themselves below or above the ALICE Threshold at different times. While the COVID-19 pandemic brought employment shifts, health struggles, and school/business closures in 2021, it also spurred unprecedented public assistance through pandemic relief measures. In 2019, 4,167 households in Green County were below the ALICE Threshold; in 2021 this number changed to 4,603, (a 10% change).

## The Cost of Basics **Outpaces Wages**

The Household Survival Budget reflects the minimum cost to live and work in the modern economy and includes housing. child care, food, transportation, health care, a smartphone plan, and taxes. It does not include savings for emergencies or future goals like college or retirement. The Household Survival Budget is calculated at the county level and varies by household composition, as costs can vary greatly depending on location and household needs.

In 2021, household costs in Green County were well above the Federal Poverty Level of \$12,880 for a single adult and \$26,500 for a family of four.


## **Financial Hardship is Not Evenly Distributed**

By addressing the disparities in financial hardship by county demographics, community members can move toward more equitable solutions.





#### ARPA Funding:

The mission of United Way of Green County is to "build a stronger community by uniting people and resources to solve problems and improve lives." The United Way of Green County has a unique perspective of community needs – unlike any other organization. In Green County, United Way works to take a hard look at the entire community, assess the needs, develop an action plan, and, most importantly, work to take action on the things that are most important. United Way of Green County is uniquely positioned to understand the needs of our entire community. We have an understanding of what the needs are based on multiple pieces of information, including things like community assessment data and the ALICE report.

Every year, requests for funding far exceed what we are able to allocate. This has been especially true the past two years as a direct result of COVID. Funding has been hard to secure for all organizations, and needs have increased. United Way of Green County was fortunate to receive a \$240,000 grant (\$60,000 per year for four years) from Green County ARPA funding as a way to fill unmet needs and can create a system for United Way to sustain funding into the future.

#### Parent Cafe Grant:

In 2021, the Green County Healthy Community Coalition completed a community survey of the most significant needs in our community. One of the most significant needs that emerged was the need to educate the community on Adverse Childhood Experiences (ACEs) and reduce them. ACEs are things like experiencing violence, abuse, or neglect, mental health problems, and other traumatic experiences early in life. In our community we know that many of our children experiencing at least one type of ACE, and one in six people reported experiencing four or more types of ACEs. We know that ACEs are common and costly. When looking long-term, the CDC's Adverse Childhood Experiences Study (ACE Study) "uncovered a stunning link between childhood trauma and the chronic diseases people develop as adults, as well as social and emotional problems. This includes heart disease, lung cancer, diabetes, and many autoimmune diseases, as well as depression, violence, being a victim of violence, and suicide (from www.acestoohigh.com)." This data is staggering, and why increasing trauma informed care, providing additional training and direct support to providers, parents and families is another critical goal of our comprehensive plan, and the focus of this grant.

A work group was formed to implement best practices for reducing ACES by identifying best practices in supporting early child development, parenting practices, and collective services. A foundation in research and best practices is a requirement for any program offered. Parent Cafes were chosen based on these criteria. The "Be Strong Families Parent Cafés" information shows that they are "a research informed practice, drawing on the research base of the Strengthening Families Protective Factors. The effectiveness of Parent Cafés is supported by over a decade of experiential evidence in communities in the US and internationally, as well as by evaluation and research conducted by independent parties in communities in California, Maryland and Missouri which suggest that our proximal outcomes are moving in the right direction to lead to our intended long-term outcomes (from www.bestrongfamilies.org/parent-cafes).

The need for Parent Cafes in Green County was determined through a needs assessment that clearly identified Adverse Childhood Experiences as a health concern in our community. In addition, work had already been done to help address infant, early childhood mental health, as well as parent and child-care provider training and support. It was clear that a larger, more comprehensive model was needed to better meet the needs of our community. To meet this need, in 2022 the United Way of Green County applied for, and received, a grant (\$30,000 a year for three years) to provide training and implementation of Parent Cafes throughout Green County.
